Mission

Fellowship House is a non-profit agency designed to service the special needs of individuals who suffer from substance use and co-occuring disorders.

Our goal has always been to provide the individual with basic living needs, a therapeutic environment, and the ability to return to society as a functional, selfsupporting, drug and alcohol free individual. We have 72 medium intensity residential beds and 42 transitional apartment beds. We offer a continuum of services that individuals can utilize through many stages of their substance use disorder and that follows with the standards of the American Society of Addiction Medicine (ASAM).

We do not discriminate against anyone on the basis of race, religion, ethnicity, sexual orientation, age, handicap, or income. Our philosophy is to treat the individual as a whole and to meet them where they are at the start of treatment. We provide this approach through intensive case management and utilizing support from community partners to address personal, social, and vocational needs. Individuals are assessed initially and ongoing throughout their treatment to determine their needs and goals. Individuals admitted to Fellowship House have a support team that consists of a case manager, clinician, recovery coach, and specialized coordinators.

Fellowship House uses the American Society of Addiction Medicine, the National Institute on Drug Addiction's 13 Principles of Effective Treatment, the Big Book of Alcoholics Anonymous, and Recovery Oriented Systems of Care as guides to our treatment methodology. Through these guides, we assist our individuals in establishing a sober, drugfree, and productive life. We use a collaborative approach to ensure that individuals get a full spectrum of care. Addiction can be a complex and deadly disease, but with the appropriate support, it is treatable and people do recover.

The goal of Fellowship House is to aid each individual in the <u>personal</u>, <u>social</u>, and <u>vocational</u> adjustments necessary for the maintenance of a sober and productive life.

Clients Served

Medium Intensity Residential

Our residential program offers a structured and supportive environment for both men and women who are unable to maintain sobriety in an outpatient or home setting. Each individual is assigned a treatment team, which consists of a counselor, a case manager, and a peer who develops an individualized treatment plan to meet their individualized needs.

Low-Intensity Apartment Program

The Low-Intensity residential apartment program allows individuals a step-down living situation. While in the apartment, individuals continue to be close and connected to treatment as they work on becoming more independent and more stable in their recovery. There are 42 beds available and there is no length of time that clients are required to stay but on average clients remain in the apartments between 6-12 months.

Medication Assisted Treatment

Medication Assisted Treatment (MAT) is a targeted treatment for individuals who have an Opioid Use Diagnosis. These FDAapproved medications include Buprenorphine and Naltrexone and aid in withdrawal management and cravings. MAT medications are prescribed and monitored by a physician and continuously managed by the treatment team to ensure effectiveness.

Jefferson County Outpatient

Our Outpatient Program in Jefferson County was established in 2019 to address the Opioid Epidemic and has since offered individuals treatment for any substance use diagnosis. This level of care enables participants to be independent while still receiving services to address their substance use. This level of care gives each individual access to a counselor, case manager, peer, and MAT physician to create an individualized treatment plan to assist with maintaining long-term sobriety.

Walker County Outpatient

Our Outpatient Program in Walker County was established in 2019 to address the Opioid Epidemic in a rural community. This level of care enables participants to be independent while still receiving services to address their substance use. While in Outpatient, each individual has access to a counselor, case manager, peer, and MAT physician to create an individualized treatment plan to assist with maintaining long-term sobriety.

She Recovers

She Recovers is an extension of our Walker County Outpatient program in conjunction with UAB and Walker Women's to provide substance use treatment to women who are pregnant and who have dependent children. Women who are a part of this program also have access to a specific curriculum and classes that target specific needs. The individuals' OB-GYN team and substance use team work together to ensure the health of the fetus, baby, and woman.

Programs

Pretreatment

Our Pretreatment program is offered twice a week to individuals who are not yet in one of our programs but who are interested in getting into treatment. During these classes, individuals are provided case management services and general assistance with stabilization. Intake Case Managers lead the classes and provide individuals with assistance to help them get into treatment and get connected to basic needs resources. Pretreatment classes provide interim services and can often help expedite the process of getting a bed at our residential facility. We partner with the Salvation Army and First Light Shelter to provide transportation to individuals who are interested in getting into a treatment program. This program helps individuals get connected to the recovery community and provides assistance with navigating the treatment process.

Co-Occurring Program

Individuals who are diagnosed with a serious mental illness, such as bipolar disorder, major depressive disorder, or schizophrenia, are engaged in a curriculum that provides classes and services that address the connection between mental health and substance use. By incorporating mental health education into their individualized treatment plan, we reduce the barriers to success and help individuals reach long-term recovery. In 2023, 44.6% of Fellowship House's clients reported a mental health diagnosis, alongside their substance use diagnosis.

Family Program

Our Family Program is offered to every individual who wants their family to be a part of their treatment experience. Each client meets with our Family and Placement Case Manager to integrate their family into their treatment and recovery process and they have access to group and individual sessions. Having a strong support network can be vital for one's recovery and this program helps to establish healthy opportunities for families to participate in the individuals' treatment. Thirty days post discharge from treatment, clients report a 4.29 out of 5 level of satisfaction with their family relationships.

Continuing Care

Every individual who leaves the Fellowship House is enrolled in our Continuing Care program so that we can engage with them after their time in treatment. Staff connects with all participants at the 30 days, 90 days, 6 months, and 12 months intervals. By connecting with past clients we can gauge our treatment success and learn ways that we can improve our services. These check-in times are also opportunities where we can provide ongoing support and recovery tools for individuals and re-engage them in treatment if they need additional assistance. Recovery is ongoing and oftentimes takes multiple attempts, so this program is a great way that we can continue to offer connections to individuals who need them.
